Vickie Wolgast updated the Board of Directors on Kansas City, MO discussion of putting a ballot issue on the August 2015 ballot to increase the minimum wage in Kansas City. The City Council will not be putting the issue on an August ballot. The Council has decided to form a Committee to discuss the matter and present recommendation to the City Council before the third week of July. Vickie has been appointed to the Committee to represent businesses in South Kansas City. She is seeking input from all South Kansas City businesses so their position is correctly reflected at the Committee meetings. The first Committee meeting is scheduled for June 1, 2015.

South Kansas City Chamber held the May morning mingle at Universal Floor Products in the Centerpoint Business Park off Highway 150. At the mingle, the developer of the business park mentioned they would be breaking ground soon on an additional 400,000+ sq.ft. warehouse. Additionally, a developer has put land under contract for a retail stripe center and a possible hotel.

V. 135th Street Phase

1, 2 & 3 Construction Update (Missy Wilson)

Phase 1: Rosehill's subcontractor has submitted hanging basket pole and bracket designs to the City for review and approval of the designs. Missy Wilson reported the subcontractor was told the designs have been sent to the City's streetlight department for review and comments should be forthcoming any day.

Phase 2 and 3: Missy Wilson reported the City Public Works Department is waiting on Water Services is to complete their review of Phase 2 designs so the City can be advertise the project for construction bids. Missy also shared Councilman Taylor is aware of the delay due to Water Services review. Councilman Taylor will work with Damon to see if the bid package can be advertised while Water Services reviews the designs.

Missy stated all parties still working with the goal to select a contractor and have the current City Council approve contract with contractor by the 3rd week of July.

At the meeting, Missy updated the Board about the upcoming PIAC hearings for 6th District. Currently the 6th District In-District hearings are scheduled for June 17th and June 29th. Citywide hearings will be in August. Missy is working with the City staff and TapanAm to prepare a PIAC application for Phase 3 of the 135th Street Public Improvements.
